MT. HEALTHY CITY COUNCIL MEETING May 7, 2013

The council meeting was called to order by President Donald Crank at 7:00 P.M. The invocation was followed by the Pledge of Allegiance.

MINUTES:

A motion to adopt the minutes as printed of the April 16, 2013 was made by Mr. Bittner and seconded by Mr. Parsons. An aye vote carried the motion.

CORRESPONDENCE:

We would like to "Thank" the Corvair Club and Karl Lemmerman for their donation to the City Parks.

PUBLIC INPUT:

Karen Arnett would like to suggest to council members to take their time on the decision making of park improvements. Most people Karen has spoke to feel disconnected from city council. Take the time and consider what the residents would want and enjoy in the park. We had putt putt golf years ago and it didn't make it and now we are going to try it again. When Karen asked kids in the park what they would like to see in the park most responded basketball courts and skateboard park. Kids today are not interested in putt putt golf. Is it really necessary to rush this?

SPECIAL PRESENTATIONS:

There has been confusion with 7272 Hamilton Avenue, so we have asked Mr. Henry to come in and let us know what the exact intent of the property will be.

Terry Bayes from Bayes and Sons Construction is here representing Mark Henry who has purchased 7272 Hamilton Avenue. Mr. Bayes has been retained for the contracting work of the property. This property is going to be a house of worship, which this does not have to go through the planning commission. There will be a chapel, 2 offices and 2 restrooms. The exterior will be re-done to make a statement for the gateway to the City of Mt. Healthy. We are following all zoning and business codes. Mr. Henry was asked to show proof that this property will be used for non-profit. This will be Universal Life Church of Cincinnati; it will be a second location.

The intent at this time is to leave the parking open for park use as long as there is not a service.

Original conversations with Mr. Henry did not indicate the property would be a church.

From the beginning of Mr. Kocher finding out he purchased the property the intent has not been clear.

Mr. Bayes was not able to answer any questions regarding exactly how the church will be run. As far as the intent of the church Mr. Bayes is not aware of. He is only the contractor.

Mr. Wolf has a concern because this is a church that when you look up on line that you can pay a fee and become an ordained minister. We need to be careful with this property and what the intent of the business that goes in.

The Mayor asked Mr. Bayes if he knows anything about 1580 St. Clair Avenue.

Mr. Bayes was not aware of anything at that address. He has been asked to look at a property that is owned by Walker Funeral Home here in Mt. Healthy, but not at that address.

Mrs. Moody brought up that she has seen the house across the street from her has been purchased and gutted. Just recently she has seen caskets being wheeled in and out of the house and there were caskets stacked in the home, which was just found out was by purchased by Mr. Henry.

1580 is zoned residential and you can't put caskets in a house. Mr. Crutchfield states they brought the property for an office or it to tear it down. Mr. Crutchfield said that was a onetime thing and it will not happen again.

Mr. Bayes did talk to Mr. Henry at the beginning about 1580 St. Clair because they did not know parking regulations and talked about the purchase of the home.

The questions council members have need to be directed towards Mr. Henry. Mr. Bayes is only able to answer contractual issues.

The Mayor would like to hear from Mr. Henry himself what the intent of this property will be.

This has made the intent of the property to be more confusing. At this point there is a lot of speculation and we just need to get a more formal intent directly from Mr. Henry.

We are going to have another joint meeting with North College Hill and have the fire chief from Deerfield Township at this meeting. We will have the meeting on Monday, June 10th at 6:30 in North College Hill council chambers. This will be a continuation of the joint fire department discussions.
