ORDINANCE NO. 14-1692

AN ORDINANCE AMENDING SEC. 50.08(C) OF THE CODE OF ORDINANCE REGARDING LATE FEES FOR WASTE COLLECTION

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MT. HEALTHY, STATE OF OHIO:

Section 1. Section 50.08(C) of the Code of Ordinance is hereby amended to read as follows:

(C) Any bill that has not been paid within the time allowed by the Greater Cincinnati Water Works shall be subject to late charges in the same amount as is applied to all late City of Cincinnati consumer's water charges, until the entire amount due (including accrued late charges) has been paid in full.

Section 2. Existing Section 50.08(C) is hereby repealed.

Section 3. This Ordinance shall be in full force and effect from and after the first date provided by law and shall be effective as of January 1, 2014.
