ORDINANCE NO. 19-1738

AN ORDINANCE AUTHORIZING PURCHASE OF A 2015 4x4 DODGE RAM 2500, 3/4 TON PICKUP TRUCK WITH UTILITY BODY FOR THE FIRE DEPARTMENT AND DECLARING AN EMERGENCY

WHEREAS, the City of Mt. Healthy Fire Department is in need of a First Responder pickup truck to replace the current one that is out of service.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MT. HEALTHY, STATE OF OHIO, TWO-THIRDS OF ALL ELECTED MEMBERS CONCURRING;

Section 1. The City Manager is hereby authorized to enter into a contract with King's Chrysler, Jeep, Dodge for the purchase of one 2015 4x4 Dodge Ram 2500, 3/4 ton, Pickup truck with Utility Body at a price not to exceed \$35,000.00, without formal bidding and advertising pursuant to O.R.C. 735.051.

Section 2. That this Ordinance is hereby declared an emergency measure necessary for the preservation of the public peace, health, safety, and welfare and shall take effect immediately upon its passage. The reason for the emergency is the recent, permanent breakdown of the current First Responder pickup truck.
