ORDINANCE NO. 15-1743

AN ORDINANCE AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT BETWEEN THE CITY OF MT. HEALTHY AND THE FRATERNAL ORDER OF POLICE OHIO LABOR COUNCIL, INC. REPRESENTING THE MT. HEALTHY POLICE ASSOCIATION SERGEANTS
